For those near Houston, join Indivisible Houston TOMORROW Monday, November 2 at 9:30 am for a "Count the Drive-Through Votes Rally and Caravan." You've likely seen that some Texas GOP members have filed a lawsuit to throw out over 100,000 ballots cast in Harris County, simply because they were done from cars instead of inside a room. While the Texas Supreme Court already threw out the case, a Federal judge is likely to hear it tomorrow.
